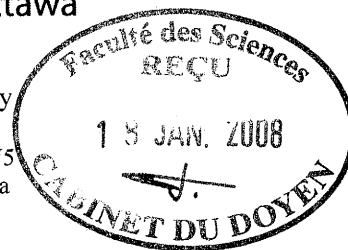

Dear Professor Lalonde,

I am writing this letter to express my serious concern regarding yet another mass-mailing from Professor Denis Rancourt, received through a distribution list he has set-up at dgr@uottawa.ca and sent from fm358@ncf.ca on Saturday, January 12, 2008. I object in the strongest terms to these communications, which I have previously indicated to him that I do not wish to receive and that I view as form of harrassment. Furthermore, I am distressed that the content of his message, continuing a trend from his many earlier mass mailings, includes a stream of factual misrepresentations and half-truths that give his communication the illusion of some sort of moral justification. These mass-mailings appear also to waste university network resources.

His behaviour, and decision to communicate untruthfully, is utterly inconsistent with any principal held dear by an institution dedicated to discovery and learning. Furthermore, the dripping contempt to which he routinely exposes his colleagues seems to be irreconcilable with the provisions of the Collective Agreement, namely Section 10.3.1, which requires that members of the APUO "shall observe commonly accepted norms of fairness and ethical behavior" toward colleagues and other scholars. Professor Rancourt's routine misrepresentation of events cannot be viewed as consistent with any commonly accepted norm of fairness or ethical behavior. Certainly, his constant disruption of even the most routine matters is beginning to make it difficult to function at the University of Ottawa and I worry this may diminish my capacity to fulfill my workload responsibilities.

Please consider this letter to constitute a formal complaint against Professor Rancourt.

Thank you for your ongoing consideration of this worrisome issue. I appreciate your helpful, and proper, actions to improve matters regarding Professor Rancourt's harmful behaviour.

OPEN LETTER TO PRESIDENT GILLES PATRY,
UNIVERSITY OF OTTAWA

RE: Executive-ordered campus arrests of community members

Dear President Gilles Patry,

Recently the executive that you head has ordered the arrests of three community members on the campus. VP-Academic Robert Major and you both publicly confirmed this at the university town hall event of December 11, 2007.

The community members were barred by use of the Trespass to Property Act because they opposed the Dean of Science's repeated violations of Faculty of Science bylaws in chairing Faculty Council meetings, even though this was done peacefully and non-obstructively.

The University is a public institution and it cannot invoke the Trespass to Property Act to bar community members from its public venues, especially venues such as Town Hall, Council and Senate meetings and public meeting areas such as the University Centre that invite public participation, in line with its Vision 2010 mission statement.

Anti-poverty activist and former Ottawa mayoral candidate Jane Scharf and independent film-maker/journalist Karen Dawe were brutally arrested in front of Gendron Hall on December 6, 2007, in order to prevent them from attending a Science Faculty Council meeting that many community members have routinely attended in the recent past.

Mr. Bob Nye, an elderly gentleman in a wheel chair and a regular participant to campus events, was arrested at the student-organized Ecofair in the University Centre on December 8, 2007, while he was hosting the Sierra Club information table as a Sierra Club member and volunteer.

The arrests of Jane Scharf and Karen Dawe involved both unnecessary use of force by a security guard and unnecessary police force, as these women offered absolutely no resistance. There were several witnesses, including myself, and much of the incident is recorded on film. Handcuffs were used causing cuts, bruising and swelling (to Jane Scharf) that I and others have witnessed. Karen Dawe was taken in a separate car and reports abusive and demeaning verbal intimidation by police.

A student was threatened and escorted off campus simply for wanting to film the arrests.

Jane Scharf was arrested a second time on December 11, 2007, in order to prevent her from attending the university town hall meeting of that day, as my guest. During this arrest, a University of Ottawa security guard

used force against her. Indeed, a police officer who was at the scene has started a police investigation concerning that use of force. Other community members were allowed and encouraged to attend the town hall meeting.

Both Jane Scharf and Bob Nye are to appear in court this month in relation to these events.

All of this constitutes abuse of power, in my opinion, since the premise used was unjustified seven-month-old trespass notices that cited attendance at a May 2007 Science Faculty Council meeting.

Under normal trespass procedures, if the person does not want to leave and does not offer resistance to police, a trespass ticket is issued and the person is escorted off the premises. The person can then contest the ticket in court.

The three trespass notices were presumably ordered by your executive. These constitute blanket and permanent orders of expulsion from campus that have not been justified or explained, that do not differentiate between different campus events, and that are politically motivated. They are intended to suppress community member participation in university collegial, democratic, and governance processes. Such suppression is in exact contradiction of the Vision 2010 mandate.

All three arrested community members have attended Science Faculty Council meetings in support of a motion to have a second-year science and society "activism course" created, that would follow the existing first-year course SCI 1101.

The dean of the Faculty of Science, André Lalonde, has repeatedly violated Faculty bylaws to block this agenda item and has cancelled the last four (4) Faculty Council meetings to prevent transparency and public participation at these meetings, again in contradiction to the Vision 2010 mandate.

I have reported the Faculty Council meeting cancellations and their circumstances here:

The actions of your executive surrounding these arrests constitute serious affronts to the mission and purpose of the university in a free society.

I ask that you repeal the trespass notices immediately. These notices are unjustified and disproportionate measures and constitute unjust treatment of community members that are integral participants in campus life.

For example, Mr. Bob Nye is distraught that he will not be able to attend the Ottawa Cinema Politica series that started on January 11th, that he has followed for the last two years.

I ask that your administration commit to not using such forceful methods as a means to suppress political expression regarding campus governance. Dialogue is better.
